# **ACCOUNTS & LOANS**

### Will my account and loan number(s) stay the same?

The majority of our account and loan numbers will remain the same, but a small group of clients whose numbers are changing will be contacted by us.

### Can I continue to use my LegacyTexas checks?

Yes. You can continue to use your remaining supply of checks and deposit slips until it is depleted.

### Will the interest rates and terms on my CDs and IRAs remain the same, and will I still receive statements?

Your CD and IRA rates and terms will remain in effect through maturity, but we will no longer send statements for CDs and will only send annual statements for IRAs.

### Is there anything I need to do to make sure my direct deposit, ACH and automatic payments/transfers continue?

No. Your direct deposit, ACH and automatic payments/ transfers will continue without interruption.

### Will the bank's routing number change?

Yes. On Monday, June 8, the routing number will change to **113122655**. However, the LegacyTexas Bank routing number will remain in place for 90 days to give you time to update your automatic transaction information.

### Will scheduled recurring transfers between my personal LegacyTexas accounts remain active?

Yes. Please note: Prosperity Bank's cutoff time is 8 p.m.

### Will there be any change to my loan rate or terms?

No, and if you have automatic payments, they will continue without interruption.

# PERSONAL ONLINE BANKING

### I currently use online banking. Will I need to sign up again after the conversion?

No. Your profile will transfer to Prosperity Bank's Online Banking. We will send you detailed information and new mobile app links closer to our conversion date.

- If you are currently enrolled in Online Statements, you will have access to up to 24 months of LegacyTexas statement history.
- Bill Pay payee and scheduled payment information will transfer, but if you use eBills, you will need to re-enroll in the new system.

### When is the last day I can log in to Online Banking before the conversion?

LegacyTexas Bank's Online Banking will be disabled at 5 p.m. on Friday, June 5. You will be able to log in to Prosperity Bank's Online Banking at 8 a.m. on Monday, June 8.

### Will my text and email alerts transfer?

No. Your text and email alerts will need to be recreated in our new system.

# COMMERCIAL ONLINE BANKING

### When can I access the new online banking system? Will I need to re-enter any information?

On Monday, June 8, you will be able to log in to our new online banking system. Login instructions will be emailed to you prior to system conversion.

Once you've logged in, you will need to re-enter the following account activities that will not transfer during conversion:

- Recurring internal transfers
- eBills
- Future dated ACH, wires and transfer payments
- Recurring ACH, wires and transfer payments
- Email and text alerts

### Will my account history, statements and templates be converted to the new system?

90 days of account history will transfer to the new system, and statements and templates will be available.

### If I use Quicken® or QuickBooks,® will my current Direct Connect enrollment still be available?

Once our system conversion is complete, you will need to update the financial institution to reflect Prosperity Bank-New. Additional information and instructions will be available as our conversion nears.
